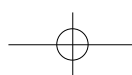


ACKNOWLEDGMENTS

She earned her B.A. degree in Sociology from the University of Puerto Rico; her M.A. in Criminal Justice from the Inter-American University of Puerto Rico; and her Ph.D. in Criminology from Florida State University. Her research and publications concern the treatment of minorities, in particular Latino(a)s in the criminal justice system; drug control; and teaching issues. She has published several articles, book chapters, and other works in the fields of criminal justice and Latino issues in the United States. Dr. Cintrón has been elected to several positions in the Academy of Criminal Justice Sciences (ACJS).

Dr. Barry Feld is Centennial Professor of Law at the University of Minnesota Law School. He received his B.A. in Psychology from the University of Pennsylvania, his J.D. degree, magna cum laude, from the University of Minnesota Law School, and his Ph.D. in Sociology from Harvard University. He has written eight books and more than sixty law review and criminology articles and book chapters on juvenile justice administration, with special emphasis on serious young offenders, procedural justice in juvenile court, youth sentencing policy, and the role of race in juvenile justice administration.
