# Preface

All it takes is to listen to the news and hear the recent stories of sexual abuse to know that sexual assault is an issue that raises many questions and concerns in the American public. We are all familiar with the cases that make headline news, but, in the world of sexual assault, the high profile cases are the rarest, and the daily business of those sex crimes that come to the attention of the criminal justice system are usually left to be done outside of much of the general public's notice.

This book attempts to fill a gap in our academic literature regarding rape, sexual assault, and in specific, the response of the criminal justice system to sex crimes. However, as the criminal justice system does not exist outside of our society, we felt it imperative to broaden the scope of the reader as well, and to include information designed to educate about the widely misunderstood crime of rape. That is why we included information about rape myths, the history of rape reform and an examination of sexual assault definitions.

Before we begin discussion of an overview of the reader we would like to make a couple of observations. First, the words rape and sexual assault are used almost interchangeably by the authors in the following chapters. That is how it is in our society as well. 'Rape' is still a crime in several states, though other states have changed the language in their criminal codes to something broader, such as 'sexual assault' or 'sexual battery'.

Secondly, most victims of sex crimes are women, and many authors chose to use the feminine pronoun in their articles when referring to victims, and the masculine pronoun when referring to offenders. Again, this was done to reflect the statistical findings that most known sex offenders are men. However, we believe that it was imperative to address the issue of male rape victims in this reader. There are several chapters, which will be discussed below, which address male victimization. Thus, we are not overlooking either male rape victims or female offenders, we are making sure that we represent a statistical reality.

And finally, we wanted to address the issue of the terms 'victims' and 'survivors'. As you will no doubt note, they are used interchangeably as well throughout and within the various chapters. We did not ask the authors to follow any guidelines in their word selection, though some addressed the issue in their writings. The reason we did this, is because this work is designed to bring the reader into the criminal justice arena. In that arena, police, prosecutors and other employees of the criminal justice system, deal with victims of crime and those who victimize others. Victimology, and the study of crime victims, is a relatively new academic component of criminal justice. We did not think it would be right to change the system phraseology. Yet, those same employees of the criminal justice system deal with the survivors of a sexual assault as well. Though some of the literature suggests that survival is a state of recovery to be achieved, we do subscribe to the belief that if you live through a sexual assault—you are a survivor.

The following discusses the various elements of this text. Disbursed throughout the book are special features that emphasize and support the reality of the factual discussions.

## Part I

#### The Crime

In part one, the reader is acquainted with the crime of rape and sexual assault. The first chapter, *An Overview of Sexual Assault and Sexual Assault Myths*, presents a look at the definitions, contradictions and statistics regarding sexual assault. The incidence and prevalence of rape are examined, and are followed with a discussion of the problems associated with an examination of rape statistics. The chapter also includes a brief history of sexual victimization, which sets the stage for much that follows in the reader. The chapter concludes with a comprehensive look at rape myths.

The second chapter *Sexual Assault Definitions* provides a general definition of rape, and offers a discussion of the parameters associated with trying to define rape. The chapter also narrows to a thorough discussion of stranger rape, intimate (date) rape, spousal rape, and group and gang rape. The third chapter *Two Crimes for the Price of One* examines the timely issue of the use of drugs as a facilitator in sexual assaults.

# Part II

### The Victims

In part two, the reader becomes acquainted with rape victimology. Chapter Four, *Victim Response to Sexual Assault* is a thorough examination of the variety of responses and coping mechanisms that survivors often experience. In addition, the chapter discusses recovery from sexual assault, seeking help and crisis intervention. Chapter Five, *The Ripple Effect: Secondary Sexual Assault Survivors*, presents an overview of the others who are impacted by a sexual assault: partners, family, and friends of the survivor. Chapter Six, *Sexual Abuse of Males*, examines male rape victims and discusses the research which suggests that male victimology can be alike, and yet quite different from female victimology. The differing circumstances of male rape are also presented.

# Part III

#### The Often Unacknowledged Victims

In part III, the reader is brought deeper into sexual assault victimology and those victim groups where we tend to see even greater underreporting are examined. Chapter Seven, *Sexual Abuse of Men in Prison*, examines the prevalence of inmate-on-inmate rape in institutions housing males. While presenting the statistics available, this chapter also includes narrative accounts from actual victims. Chapter Eight, *A Violation of Trust and Professional Ethics: Sexual Abuse of Women Prisoners by Correctional Staff*, examines the issues of female inmates who are victimized by institutional employees. Chapter Nine presents an overview of *Child Sexual Abuse*. Chapter Ten presents a moving account of one survivor's journey from victimization as a child to resolution in *Reading Incest: Interpreting Signs of Victimization and Family Dysfunction in One Survivor's Account*. Chapter Eleven, *Critical Needs for Effective Criminal Justice and Public Health Responses in Preventing Elderly Sexual Abuse*, presents an overview of sexual abuse of the elderly as well as some policy recommendations in dealing with this issue.

## Part IV

## The Offenders

Part four offers a comprehensive discussion of sex crime offenders. Chapter Twelve, Sex Offenders and Child Molesters, offers a thorough discussion of many aspects of those who rape. The chapter begins with a discussion of human behavior and motivation. The chapter continues with a discussion of sex offender typologies—the attempt to classify sex offenders into different groups based on their motivations, choice of victims and actions during the attack. This chapter also discusses classifications of child molesters. Chapter Thirteen, Juvenile Sex Offenders, discusses the delicate issue of youth that commit sex offenses against others including the extent of the problem, how juvenile sex offenders compare to other juvenile offenders and sexting, a new class of juvenile sex offenders. Chapter Fourteen, Sex Offender Treatment, What Works, Who Works and New Innovative Approaches, presents an overview of various treatment methods currently used with sex offenders.

## Part V

## The Criminal Justice System

Part five overviews the various components of the criminal justice system as they address the issues of sexual assault. Chapter Fifteen presents *A Brief History of Rape Law and Rape Law Reform in the United States*. This chapters offer a discussion of the roots of American rape law and the major changes in rape law that were initiated in the 1970s. This discussion will lead the reader into the chapters regarding police investigation, prosecutorial duties, and correctional treatment. Chapter Sixteen addresses issues regarding *The Police and Victims of Sexual Assault*. Chapter Seventeen examines why rape has historically been the most under prosecuted crime in *Prosecution of Sex Crimes*.

## Part VI

## Public Fear and Legislative Response

Part six addresses the legislative response to sexual assault. With public sentiment suggesting that the criminal justice system was failing in rehabilitating or incapacitating sex offenders, the legislature stepped in and created new laws

that would address this issue. Chapter Eighteen, *Sex Offenders, The Social Narrative and Public Policy Implications,* discusses the rational and effectiveness of recent public policy concerning sex offenders. Chapter Nineteen, *Sex Offender Laws: Some Legislative Responses,* presents an examination of the creation of registration, notification, sexual predator and chemical castration laws, to name a few. This chapter also addresses concerns expressed regarding the constitutionality of these laws.
