### **Series Note**

The Legal Research Series published by Carolina Academic Press includes titles from many states around the country. The goal of each book is to provide law students, practitioners, paralegals, college students, laypeople, and librarians with the essential elements of legal research in each state. Unlike more bibliographic texts, the Legal Research Series books seek to explain concisely both the sources of state law research and the process for conducting legal research effectively.

### Preface and Acknowledgments

The primary audience for this book includes first-year law students enrolled in a course that integrates hands-on legal research with legal analysis and writing. Other audiences include practitioners who need to become familiar with researching Michigan resources as well as paralegals, college students, and anyone else seeking an understanding of Michigan authorities.

Our interest in writing this book stemmed in large part from students' frequent requests for a text devoted primarily to Michigan resources. In writing the text, there are five goals. First, create a short, readable text that introduces the process of researching problems in Michigan, as well as provide basic information regarding the federal system. Second, provide guidance on how to determine the authoritative value of various types of legal sources. Third, include brief discussions of legal analysis to demonstrate the intersection between the process of research and writing. Fourth, provide a method for systematically keeping track of the research process. Fifth, emphasize the importance of effective and efficient research.

This last goal led to an appreciation that, in some situations, the most effective and efficient research begins with online resources. In explaining online sources, we have chosen to provide fewer in-depth details about how to create searches for various sites. This decision was a result of feedback from students who used the manuscript in class and confirmed our view that students need to know the site, what to look for, and how to analyze what they find, not detailed information on how to search each site.
