Glen Weissenberger is former Dean of DePaul University College of Law. He previously taught at the University of Cincinnati Law School for 27 years, rising to become the Judge Joseph P. Kinneary Professor of Law. During this time, he served as special counsel to the university president and as director of the university's Center for Studies in Professional Skills. He received many teaching and scholarship awards, including the Ohio State Bar Foundation Outstanding Research Award, the University of Cincinnati Faculty Achievement Award, and the Jerome P. Goldman Prize for Teaching Excellence. In 2005, he was appointed chair of the Editorial Advisory Board of LexisNexis Legal Publishing, one of the largest legal publishers in the United States. Weissenberger earned his Juris Doctor from Harvard University in 1972 and a Bachelor of Arts degree from the University of Cincinnati in 1969. A prolific scholar, Weissenberger is the author of many works found in libraries and classrooms across the nation. Weissenberger's Federal Evidence is commonly cited in law review articles and texts on evidence law, while its companion work, Weissenberger's Federal Evidence Courtroom Manual, has been published annually since 1992.

James J. Duane is a Professor at Regent Law School in Virginia Beach, Virginia. He has taught as a Visiting Professor at William & Mary Law School, and at the National Trial Advocacy College conducted each year at the University of Virginia School of Law. He was awarded the Distinguished Faculty Achievement Award by the Virginia State Council of Higher Education in 2002. Professor Duane is a member of the Panel of Academic Contributors to *Black's Law Dictionary*, and has published more than thirty articles in the field of evidence law. He is admitted to practice in New York and Virginia, and before the Supreme Court of the United States and several other federal courts. He received his A.B. *magna cum laude* from Harvard College in 1981, where he was Phi Beta Kappa, and his J.D. *cum laude* from Harvard Law School in 1984. He clerked for the Hon. Michael A. Telesca of the United States District Court for the Western District of New York, and the Hon. Ellsworth A. Van Graafeiland on the United States Court of Appeals for the Second Circuit, before practicing with Connors & Vilardo in Buffalo, New York.
