This book, we hope, will be included in future lists of well-written and groundbreaking books about the Holocaust. It is the first law school casebook to examine the Holocaust. And as a casebook, it is the first book of any kind to tell the story of the Holocaust and its aftermath through the use of U.S. judicial opinions. Our aim is to enrich the law school experience and aid students in becoming more sensitive and thoughtful lawyers.

The research for this book closed on September 1, 2017. Because of space limitations, we had to make very difficult choices about what to include and what to omit. To compensate, numerous references to other works about the Holocaust appear throughout our commentary.

As editors, we have not indicated where material has been corrected, reordered, or excised, except when not doing so would create confusion. Similarly, we have converted all footnotes to text without further elaboration. With respect to citations, we generally have followed the *Bluebook*, but have deviated from it whenever we felt doing so improved clarity.

Like all authors, we need to repay some debts. We are especially grateful to our publisher, Dr. Keith R. Sipe, and all the folks at Carolina Academic Press who believed in us and helped make our vision a reality.
