He is a member of the Scientific Committee of the *Fondation pour le Droit Continental*; he is president of the Louisiana Chapter of the *Association Henri Capitant* and of the *International Association of Legal Methodology*. He has published extensively in the fields of Comparative Law, Civil Law (Civil Law System/Tradition, Obligations, Contracts, Sale/Lease, etc.), EU/EC Law, and U.S. Law (in French with Dalloz). He has been a regular visiting Professor at the Universities of Aix-Paul Cézanne and Lyon III. He has been honored with two Doctorats Honoris Causa, one from the University of Aix-Marseille Paul Cézanne (1999) and another from the University of Paris-Panthéon Assas (2010).
