### **Preface**

This workbook is based on fictional residents of Harmville, a fictional town. These residents provide the scenarios for hypothetical exercises that are integral to effectively build and hone writing and practical legal skills pertinent to tort law. Each chapter also includes a checklist, though not exhaustive, of key interview questions to ask a client. Additionally, at the end of each chapter, the user is provided with a self-assessment tool, which can be used to evaluate the user's performance of these tasks.

This workbook may be used in a number of ways. The professor may assign chapters and exercises to be completed outside of class and direct students to use the checklist provided in each chapter as a self-assessment tool. Alternatively, the professor may assign a chapter to be completed outside of class, collect the assignments, and assign a grade to the work product. This workbook may also be used during class as a guide for in-class discussion and, depending on the class size, for in-class group presentations, or role play. This will allow for both individual and group assessments, which support the learning process and enhance skill-building. This workbook may also be used by individuals who plan to take the Bar exam and wish to use it as a study guide. This workbook is also designed to be used as a tool to assist new attorneys, who plan to practice Tort Law and Personal Injury Law. It is also an excellent resource for paralegals.
